“Force Majeure” and Other Restrictions

We have all experienced, with COVID-19, the impacts of unexpected “Force Majeure” events outside our reasonable control. Should FACTS Management be prevented from conducting this event due to any of the following causes to the extent beyond its reasonable control: acts of God, accident, riots, war, terrorist act, epidemic, pandemic (including the Covid-19 pandemic), quarantine, civil commotion, breakdown of communication facilities, breakdown of web host, breakdown of internet service provider, natural catastrophes, governmental acts or omissions, changes in laws or regulations, national strikes, fire, explosion, or generalised lack of availability of raw materials or energy, alternate options for Platinum sponsors will apply, including reduced investment and different inclusions.

FACTS Management Australia will be subject to these plans, and sponsor package options may change to reflect such requirements.
