Chapter One

The Federal Funding Opportunity

Authorized by the Elementary and Secondary Education Act (ESEA) and amended by the Every Student Succeeds Act (ESSA), Title I, II, and IV are key federal grant programs that aim to improve educational equity in the United States.

These funds provide private schools with critical resources to implement interventions for struggling students, enhance teacher professional development opportunities, and enrich learning experiences.

Private schools do not receive these funds directly. Instead, they partner with Local Educational Agencies (LEAs) or third-party providers to access eligible services. This reduces administrative burdens for the private schools and allows them to maintain their autonomy while benefiting from valuable resources.



Let's dive deeper into the opportunities available under each of these programs.

Title I: Supporting Academic Achievement

Title I aims to provide all children with the opportunity to receive an equitable and high-quality education and to close achievement gaps. Through this program, private schools can provide their low-income students with interventions like tutoring, remedial programs, and enrichment activities that boost academic success.

Title II: Building Teacher and Leader Capacity

Title II funding supports the growth and effectiveness of teachers and school leaders to enhance instructional quality and leadership effectiveness. With these funds, private schools can access professional development opportunities including workshops, certifications, and group or one-on-one training.

Title IV: Creating Well-Rounded Educational Opportunities

Title IV gives private schools needed resources and flexibility to improve student academic achievement and enrich learning experiences for all students. This funding supports educational programs related to STEM, the arts, wellness, and technology.





Chapter Two

Equitable Services and How They Work

In chapter one, we discussed programs offered under the Every Student Succeeds Act (ESSA). These programs provide private schools with equitable service, which ensure students and educators have fair access to federally funded resources comparable to services provided to public schools. These services are proportional to students' needs and do not compromise a private school's operational independence.

Key Aspects of Equitable Services

Consultation

Local Educational Agencies (LEAs) are required to engage in timely and meaningful consultation with private school officials to identify needs, allocate funds, and plan services. LEAs may distribute documents to private schools such as a "Declaration of Participation" or other invitation to participate. It is common for LEAs to indicate a timeline for private schools to respond to their request for information. For private schools interested in accessing Title funding, responding within any identified timelines is important.



During the consultation between an LEA and a private school, topics of discussion include program size, delivery methods, and use of third-party providers.

Equitable Share

LEAs allocate services to private schools in their region based on the proportionate number of eligible students enrolled in each private school, often calculated on a per-pupil basis. The goal is to address the needs of students who are the most at risk of academic failure.

Ombudsman Role

State Educational Agencies (SEAs) designate an ombudsman to serve as a neutral arbiter, monitoring and enforcing the implementation of equitable services. The ombudsman supports the process in several ways including:

- Participating in the consultation process to ensure best practices are followed
- Settling any disputes between LEAs and private schools
- · Accessing budget information and overseeing the equitable share process
- Monitoring program completion and compliance



Service Delivery

Private schools may receive services directly from their LEA or through a third-party provider. FACTS is an example of a third-party provider that offers professional development, coaching, and instructional services to help private schools get the most out of their Title services.

Complaint Process

Private schools have the right to file complaints if they believe their LEA has not fulfilled its obligations regarding consultation or service delivery based on statutory requirements. The complaint process safeguards private schools and ensures accountability and fairness in private schools' equitable participation in federally funded programs.

Concern

My School Will Lose Autonomy

Each private school has a distinct identity, educational philosophy, and instructional approach that they offer to their students. For many schools, the idea of accessing federally funded services presents a fear of losing control over the curriculum and operations that make their school unique.



Autonomy Is Protected

Federal services do not dictate a private school's operations. Rather, they supplement the good work that private schools already do. The ESSA process includes safeguards that protect the private school's autonomy and ensure that they maintain control over their curriculum and operational practices.



Concern

Navigating Funding Is Too Complex

Private school leaders are busy and have full plates. The ESSA process involves a lot of steps from preparing for the LEA consultation to submitting documentation to overseeing the implementation of services. Because of this, some private school leaders worry that the process is too bureaucratic and tedious to be worth their time.

- Understand Your Rights: Familiarize
 yourself with what your school is
 entitled to under federal law. Exploring
 EveryStudentSucceedsAct.org is a good
 place to start. If you would like guided

- 2. Gather Documentation: When you meet with your LEA, you will want to present a comprehensive needs assessment. Collect data and any relevant documentation to demonstrate your school's needs.
- Define Your Priorities: Focus on programs that will deliver the greatest impact to your students and teachers.



Once funding is allocated, prepare to discuss with your LEA how you would like to implement your designated funds. Your LEA will likely offer to send their personnel to your school to enact services. Or, if you prefer, you can elect to work with a third-party provider, such as <u>FACTS</u>, to implement your Title-funded services.
